## II. Privacy Policy

The operator is responsible for the collection, processing and use of your personal data within the meaning of the German Data Privacy Act (BDSG) and the German Telemedia Act (TMG). ### A. Scope and purpose of the collection, processing and use of personal data when visiting this website

The following data is automatically recorded without any action on your part and stored for a period of six months: -Date and time of access, -Name and URL of the accessed file, -Operating system of your computer and the browser that you use, -IP address.
