## II. Privacy Policy

The operator is responsible for the collection, processing and use of your personal data within the meaning of the German Data Privacy Act (BDSG) and the German Telemedia Act (TMG). The operator has implemented numerous technical and organisational measures to ensure the most complete protection of personal data processed through this website. Any personal data is used in compliance with the applicable data privacy provisions. Below you will find the needed information of how personal data is handled in relation to this website. ### A. Scope and purpose of the collection, processing and use of personal data when visiting this website

With every visit to this website there is information being stored temporarily in so called log-files (access-log, error-log) that are saved on the hosting server (provider: HostEurope). The following data is automatically recorded without any action on your part and stored for a period of six months:

- Date and time of access,
- Name and URL of the accessed file,
- Operating system of your computer and the browser that you use,
- IP address.

This data is collected and processed for the purposes of facilitating use of this website (creating the connection), guaranteeing long-term system security and stability, for technical administration and optimising this web service, and for internal statistical purposes. The data will be deleted automatically after a period of six months.

In addition, there are also cookies created during visiting this site. You can find more detailed information on cookies at paragraph 2.E., further below.

### B. Transfer of Data to Third Parties

There will be no transfer of personal data to third parties until the user has expressly agreed to this or if the operator will be under a legal obligation to do so. Transfer to third parties for other purposes will not take place.

## C. Right to Information, Correction, Blocking and Deletion

You have a right to information regarding your personal data as well as a right to correct incorrect data, or to block and delete such data. For information on your personal data, to have incorrect data corrected, to have data blocked or deleted, or for further questions on the use of your personal data, please contact the operator.

## D. Data Protection

There will be no analysis of personal data (e.g., name, address or e-mail address). If personal data is being collected, this only occurs, to the extent possible, with the prior consent of the user of the website, or by for example sending an email to the operator.
