## II. Privacy Policy

### A. Scope and purpose of the collection, processing and use of personal data when visiting this website

This data is collected and processed for the purposes of facilitating use of this website (creating the connection), guaranteeing long-term system security and stability, for technical administration and optimising this web service, and for internal statistical purposes. The data will be deleted automatically after a period of six months.

## **B. Transfer of Data to Third Parties**
